On the morning of day five, the Certified Energy Manager (CEM) examination will be administered to seminar participants who have applied and pre-registered for the exam in advance.

There is no obligation to write the CEM exam on the last day of the 5-day training course. Persons who are interested in attending only the 5-day energy management are free to do so. It is preferred that you register in advance if you want to write the CEM exam and submit your CEM application. However, if you decided not to write the CEM exam but change your mind during the course to write the exam we will accommodate you. You will then have to submit the CEM application afterwards. Persons attending the 5-day CEM Course will receive a certificate of attendance.

ELIGIBILITY AND COSTS:

Eligibility:

The prerequisites to qualify for the certification process have been designed to take into account the possible diversity of education and practical experience an individual may have. However each CEM candidate must meet one of the following criteria:

- A four-year engineering or architectural degree, or a registered Professional Engineer (P.E.), or Registered Architect (R.A.) with at least three years experience in energy engineering or energy management.
- A four-year business or related degree, with at least five years experience in energy engineering or energy management.
- A two-year technical degree, with eight years experience in energy engineering or energy management.
- Ten years or more verified experience in energy engineering or energy management.

Costs:

It is important to note that full payments will have to be received at least one month in advance. If you are interested in attending the 5-day course and write the exam, we should have received your payment by 15 Feb 2010.
